Teaching in the Pandemic






The Pandemic impacted every aspect of school and district operations. Some key accomplishments and facts:



Guidelines – Strategy and Tactics



Strategy

- ☑ Rebuild reserves as enabled by Federal and State funds (e.g. food service)
- Develop a flexible budget that is responsive to uncertainty caused by the pandemic.

Tactics

- Assume uncertainty regarding state and federal funding for schools.
- ▼ Evaluate Kindergarten Enrollment Projections carefully in light of fluctuations last year.
- ☑ Evaluate All Day Kindergarten tuition in light of resumption of All Day Kindergarten during FY22.
- Maximize alternative revenue sources, including, but not limited to state and federal grants.



FY-21 Budget Closeout

COVID Grants, Contingency, Reserves (E&D)



Maintaining a healthy reserve, is a key element in strategic budgeting

- FY21 budget appropriated \$1.5M from E&D as a revenue source, and provided a pandemic contingency of \$500K
- Four grants were used to significantly address COVID related needs:
 - FEMA, ESSER, CARES and CvRF
- The grants funded approximately \$3.4 million of expenses
 - Facilities, PPE, Technology and Food Service
- The grant funding allowed us to protect the contingency balance, which will return to E&D at year end
